Refund Policy

Our refund policy at Base Line Data Career Center, Inc. is based on the period of enrollment computed on the basis of course time (*clock hours*).

The effective date of termination for refund purposes will be the earliest of the following:

- a) last date of attendance
- b) date of receipt of written notice from the student

If tuition and fees are collected in advance of entrance (*first day of class*), and student does not enter school, no more than \$100.00 shall be retained by school.

If the student fails to enter the seminar, withdraws, or is discontinued at any time prior to the completion of the seminar, the student will be refunded the prorated portion of tuition, fees, and other charges which the number of class hours remaining after the effective date of termination bears to the total number of class hours in the seminar.

National exam fees remitted are exempt from this policy, as all exam fees collected by Base Line Data Career Center, Inc. are submitted directly to the organization issuing certification, *i.e.* American Welding Society, American Petroleum Institute. These fees therefore fall under the refund policy of the organization they were submitted to.

A full refund of all tuition and fees is due in each of the following cases:

- a) an enrollee is not accepted by the school
- b) seminar is discontinued by the school and thus prevents the student from attending or completing the seminar
- c) student's enrollment was procured as a result of any misrepresentation in advertising, promotional materials of the school, or misrepresentations by the owner or representatives of the school

Refund Policy for Students Called to Active Military Service

A student of the school or college who withdraws from the school or college as a result of the student being called to active duty in a military service of the United States or the Texas National Guard may elect one of the following options for each program in which the student is enrolled:

- a) any tuition and fees collected in advance of the withdrawal, prorated refund of any tuition, fees or other charges paid by the student for the program and a cancellation of any unpaid tuition, fees, or other charges owed by the student for the portion of the course the student does not complete following withdrawal
- b) a grade of incomplete with the designation "withdrawn-military" for the courses in the program, other than courses for which the student has previously received a grade on the student's transcript, and the right to re-enroll in the program, or a substantially equivalent program if that program is no longer available, no later than the first anniversary of the date the student is discharged from active military duty without payment of additional tuition, fees, or other charges for the program other than any previously unpaid balance of the original tuition, fees, and charges for books for the program; or
- c) the assignment of an appropriate grade or credit for the courses in the program, but only if the instructor or instructors of the program determine that the student has:
 - a. satisfactorily completed at least 90 percent of the required course work for the program
 - b. demonstrated sufficient mastery of the program material to receive credit for completing the program

Refunds will be consummated within sixty (60) days of the effective date of termination.

Drop-In or Returning Student Policy

Students signing up for the day or night classes are also allowed to attend the night or day class, participate in Saturday and Sunday test taking or stay after the normal class period to practice, all included in their original course fee. This cost is only good for the month that the course is being presented.

The student that puts off or is unsuccessful on his examination and requires additional training, use of controlled test, tools or plastic replicas will be charged a reduced fee for this extra service. This additional cost will be addressed with the course coordinators prior to being allowed entrance into the testing site. Each student will be issued a scan badge that must be scanned at the beginning and end of class. This controls the training hours for certification.

Purchase of additional training material, tools, and replicas can be discussed with the class instructor. Upgrade of revised training material, such as Exhibit or Flashcard books will be charged an additional fee. Books that are revised during the month of training will be upgraded at no extra cost.
